A Woman's Place provides free, confidential, comprehensive services to victims/survivors of domestic violence. In 2018, A Woman's Place advocates assisted a total of 470 survivors with safe shelter and provided 6,633 nights of stay. Advocates answered 927 crisis calls and provided 107 clients with legal advocacy services. Throughout the year, advocates assisted victims with safety and self-sufficiency through 24-hour services and programs such as crisis line coverage, emergency shelter, individualized goal planning, parent and children programs, and support group.

Advocates assisted 139 victims with nonresidential services to include 282 hours of prevention and intervention counseling, assistance with temporary and permanent protection orders, advocacy, safety planning, and resources and referrals. A Woman's Place offered 121 different education and awareness events to Weld County.

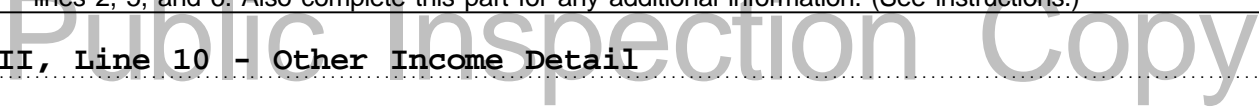

Volunteers are utilized in every aspect of a Woman's Place. Some individuals receive full training and provide advocacy and crisis line coverage; some provide assistance sorting donations and other non-direct services. The Organization received 2,386 hours of contributed services consisting primarily of victim advocate support valued at \$58,910.

Form 990, Part III, Line 4c - Third Accomplishment

In 2018, advocates provided 374 youth and family services such as: Sensory Play (a program that promotes cognitive and socio-emotional development through the engagement of the senses); Family Activities (regularly scheduled events designed to help youth heal from trauma through family bonding); and childcare support (to give guardians the time to focus self-sufficiency activities, such as seeking employment or sustainable housing). In addition to providing services to help empower victims of domestic violence, AWP also works to address the root causes of domestic violence by providing community education. In 2018, AWP advocates gave 11 community education presentations; 27 trainings to professional organizations; and 44 community awareness activities. In order to disrupt the cycle of violence in future generations, AWP makes a concerted effort to educate young people. In 2018, AWP's Outreach Director gave 14 youth-targeted presentations at Weld County high schools. In terms of educating our clients, 95% of respondents to AWP's 5-day survey reported an increase in safety knowledge and 94% reported an increased knowledge of community resources as a result of safety planning with AWP advocates.

The Organization screens for nepotism and does not hire individuals if they are related to another staff member. The Executive Director monitors conflicts of interest at the Safe House. In addition, board members are required to inform the other members if a conflict of interest exists.
